1.	The Supplier rents out to the User the following instrument:

2.	The User confirms and undertakes that the instrument will ONLY be used by:

3.	The User takes full responsibility for all risks including loss or damage to the instrument and undertake to fix or replace the instrument or parts of the instrument at own cost as a result of negligence by the User.		
4.	The User agrees to pay a REFUNDABLE DEPOSIT of <b>R800-00</b> for this instrument as soon as lessons commence.		
5.	The User acknowledges that the instrument was received in good working condition. Should there be any visible signs of damage upon receiving the instrument, the User should let the Supplier know in writing within 14 days from the date of reception.		
6.	The User admits that he/she has no right towards the instrument except as concluded in this contract		
7.	The User undertakes that should lessons be stopped for any reason, the instrument will be returned immediately to the teacher or Supplier without hesitation.		
8.	The User agrees that should the instrument be received back by the Supplier with any damages to the instrument that was not mentioned in writing upon receiving the instrument, repairing costs will be deducted from the refundable deposit, after which the difference will be refunded to the User.		
9.	In the case of a lost or stolen instrument, the User can choose to replace the instrument with exactly the same make and model OR to pay to the supplier the following amount (as per instrument/make/model and replacement value). Cost		
10.	Both parties admit to the jurisdiction of the Magistrate's Court in the case of a dispute or reaction or any other incident which may be the result of this agreement.		
11.	Both parties admit that this agreement concludes all aspects of the agreement between them and that any change thereof must be done in writing and signed by both parties.
